I agree that FCSSC, its officers, directors, employees, volunteers, and independent contractors will not be liable for any illness or injury, including, without limitation, personal, bodily, or mental injury, economic loss or any damage to myself, my spouse, guests, unborn child, or relatives resulting from the act or omission of FCSSC or anyone on FCSSC's behalf or anyone else whether related to the Activities or not. I agree to indemnify, defend and hold FCSSC harmless against any liability, damages, defense costs, including lawyers' fees, or from any other costs incurred in connection with claims for illness, bodily injury, wrongful death or property damage caused by my own act or omission. - **5)** Hazards: I willingly agree to comply with the stated and customary terms and conditions for participation. If, however, I observe any unusual significant hazard during my presence or participation, I will remove myself from participation and bring the hazard to the attention of FCSSC's representative, on site, by phone or email.

- (a) the legality, validity, or enforceability of the remaining provisions of the Agreement, in whole or in part; or
- (b) the legality, validity or enforceability of that provision, in whole or in part, in any other jurisdiction.
